Course Registration Policies

The following restrictions apply to Government & Politics courses:

- 400-level GVPT courses are restricted to GVPT majors only.
- The department does not oversubscribe students into courses that are full. The department follows the waitlist policy strictly.
- Non-GVPT majors may only take 1 GVPT course per semester (100-300 level). GVPT majors may only take 3 GVPT courses per semester.

Waitlist and Holdfiles

Seats on hold

You may notice that GVPT courses listed on Testudo have slightly smaller seat totals than usual. This is because the department has kept a few seats reserved in each course in case of advising emergencies. On the first day of classes, all seats will open up, so the first few students off the waitlist will likely get a seat in the course.

What is a waitlist or a holdfile?

The waitlist is the virtual "line" to get into the class. As a seat becomes available, the first student "in line" will earn that spot. The department follows the waitlist strictly - students can't cut in line by being oversubscribed.

The holdfile is similar in that it is a line for the course; however, the holdfile is for students who do not meet the initial qualifications for the course. This could be that they are not GVPT majors, do not have enough credits, or do not meet some other restriction. After the first day of classes, the holdfile merges with the waitlist---students who are on the holdfile are put at the end of the waitlist line.

STAFF AND ADMINISTRATION

MAKE-UP EXAMS (Proctoring)

The main office staff does not proctor or oversee make-up exams. Make-up exams will not be held in the GVPT main Office Conference Room.

RETURNING STUDENT PAPERS

The main office staff does not collect or return student papers. If you want to provide a pick-up service, give the students a time when you will be in your office for them to pick the papers up. Leaving papers out for the students to flip through is a violation of student privacy. The best suggestion is to ask the students to provide a self addressed and stamped envelope and you will return the papers to them.

INSTALLING Personal Network Devices IS PROHIBITED

Please refrain from connecting your own networking devices to the campus network. Not only is this a violation of the Policy on the Acceptable Use of Information Technology Resources (<http://www.nethics.umd.edu/aup/>), but also could cause much disruption to you, your colleagues, and our students. Such disruptions may be as serious as multi-building wide network outages (i.e., entire building data and voice services become unavailable).

If such a device is found on the network (i.e., a wired or wireless device that can hand out IP addresses) the device owner will be referred to the Division of IT's Security Office and their device will be confiscated.

If you have needs that you feel the campus network cannot fulfill, please contact OACS. We will work with you and our network and security offices to devise a networking solution that works for you, yet is in compliance with the campus' security rules and regulations.

Jack was an integral part of the department since 1988. Over that time, he masterfully taught thousands of students, most notably, educating them on the nation's complex legal system. Along the way, as teacher and advisor, he has shepherded many of our students onto law school and careers as successful attorneys. Known for his keen intellect, great sense of humor, comradeship, and love of rock-and-roll, Jack will be sorely missed. Jack received his B.A. from the University of Maryland Baltimore County, his J.D. from the University of Maryland Law School, and his Ph.D. from the University of Maryland College Park.

Judson, Janis Ph.D. 1986, has been a full time faculty member at Hood College in MD for 33 years. She chaired the political science department from 2011-2013 and was promoted to full professor in 2014. Judson is currently serving as the chairperson of a brand new department---Law and Criminal Justice. She has been studying human rights and law. In 2013 Judson was one of 20 academics chosen by the ICTJ to attend the transitional justice workshop in Barcelona, Spain and last year she met with the President and the cabinet of Iceland as researcher in restorative justice.

Center for American Politics and Citizenship (CAPC)

CAPC Latino Research Fellowship

I wanted to share an opportunity that the Center for American Politics and Citizenship is offering this fall. The Center has been awarded funds by the American Political Science Association's Fund for Latino Scholarship to offer two undergraduate research fellowships to students of Latino/Hispanic descent. This is an effort to recruit students from a historically underrepresented group and to provide them exposure to doing research in the hopes that they will be interested in pursuing graduate training.

[Program Description](#)

The Center for American Politics and Citizenship (CAPC) has been granted funds by the Fund for Latino Scholarship at the American Political Science Association to hire two Research Fellows. The fellow should be interested and excited about the possibility of going to graduate school in a social science field. Preference will be given to those who are interested in pursuing graduate studies in political science and who are interested in issues of race and ethnicity. Fellowship applicants should have a strong undergraduate record (at least a 3.0 GPA), and should be committed to issues of diversity, inclusion, and social justice. The fellow will work with faculty, graduate, and other undergraduate students. The student should have completed a minimum of 30 credit hours (preferably 60). The selected fellow will be expected to work 10 hours a week and will be compensated at the rate of \$12 an hour.

[CAPC Research Program Information](#)

The CAPC Research Assistantship Program is for students interested in developing their research and professional skills as well as gaining a deeper understanding and appreciation of the study of political science. Research Assistants (RAs) are paired with a faculty member who directs their research for the semester as well as helping them develop a unique project based at least in part, on the research they are conducting on behalf of the faculty member. In addition, students are also assigned a graduate student to help mentor and guide them through the research process. RAs are also given formal training in writing, data analysis, public speaking/presentation skills, conducting academic research, and formulating cogent research questions.

The following materials are required for the application (priority deadline August 25, 2017)

1. Cover letter with contact information, major, class standing, UID, and contact information of a professor who will serve as a reference.
2. A current unofficial transcript
3. One page resume of your educational and employment background. Courses relevant to American politics (or other political science field) and policy and educational experiences should be emphasized
4. A writing sample, such as a short paper.
5. A 500-700 word essay on the following question: *"How has increasing racial and ethnic diversity within the United States affected contemporary ideas of democracy? Has it expanded how we talk about the term? Contracted it? Or something else entirely?"*

The First Political Order: Sex, Governance, and National Security With Professor Valerie Hudson

Abstract: The first political order is the sexual political order. How the character of male-female relations develops within a society has profound effects on nation-state level phenomena, including food security, health, economic prosperity, demography, governance, and intra- and inter-state conflict. Mixed-methods research, including large-N statistical analysis, shows a deep divide in behavior and outcomes between societies encoding an inequitable sexual order versus societies encoding a more equitable order. The clash of civilizations is not best understood in Huntington’s terms, but rather in terms of a clash between two divergent sexual political orders.
